Letters requesting TIP (Transportation Improvement Program) amendments must be submitted well before the mail-out deadline, so that they can be reviewed, included in the mail-out, and received by Committee members for their review before the meeting date.

All letters requesting TIP amendments are considered “draft” and must be reviewed and approved for completeness and accuracy by CDTC staff. This includes significant coordination between CDTC, the project sponsor, and NYSDOT. TIP amendments examples are found in the TIP document on our website.

Letters requesting TIP amendments are welcomed any time before the dates in Column 3.
